

**ORDINANCE NO. 2018-8
WESTCHESTER PARK DISTRICT
ANNUAL LEVY ORDINANCE FOR THE YEAR 2018**

**BE IT ORDAINED BY THE BOARD OF PARK COMMISSIONERS OF THE
WESTCHESTER PARK DISTRICT, COOK COUNTY, ILLINOIS, AS FOLLOWS:**

Pursuant to authority vested in them by the Park District Code, Article Five, the Commissioners of the Westchester Park District Board in meeting assembled do hereby find and declare that there will be required to be raised by general taxation the amounts hereinafter set forth to be levied upon all the taxable property in said Westchester Park District, in order to meet and defray all the necessary expenses and liabilities of the Westchester Park District as required by statute or voted by people for uses and purposes as follows, to wit:



Making the aggregate sum, exclusive of the Bond and Interest Fund, One Million, three hundred thirty thousand, one hundred sixty six dollars (\$ 1,330,166.00) to be raised by taxation and levied on all taxable property in said Westchester Park District, for the year 2018, in order to meet and defray all the necessary expenses and liabilities of the Westchester Park District as required by statute or vote by the people in accordance with the law.


