#### DOG PARK

Mr. Kasanders reported the dog park group received a donation of \$10,000 for the naming rights to the dog park. Mr. Kasanders also notified them that it is their choice to pick up the check in lieu of us holding it, which is what they did. Mr. Kasanders also reported he approached the Village regarding the dog park with the request that we use part of the parkway for the dog park, allow the Park District to have the curb cut for ADA access and place a handicapped parking sign next to the rolled curb. Mr. Kasanders also requested to bring water to the site for a drinking fountain. The above mentioned would need to be approved by the Village Board.

Mr. Kasanders also reported the Dog Park Group would like to use the Mayfair banquet room for a fund raising venture, which would involve a dinner with a silent auction. The date has been reserved for April 22<sup>nd</sup> and the reservation is currently under Mr. Kasanders. The Park District would sell tickets for the event and anyone can purchase a ticket and attend the event. The Board had discussion on naming the dog park and the collection of funds.

President Busa asked Mr. Kasanders to prepare and present the Board the necessary paperwork needed to move forward with the Dog Park fundraiser event. The Commissioners will then vote and take action at the next meeting. Mr. Kasanders will also present drawings and more information to the Commissioners at the next board meeting.
